NOMINATION FOR ELECTION OF OFFICERS FOR YEAR: 2007

INSTRUCTIONS / RULES

1. **Constitution: ARTICLE VII (Executive Committee) & VIII (NOMINATIONS AND ELECTIONS)**
 - A. Any current member who is eligible to vote, and has served one full term in good standing, including the current term, in executive committee, trustee board, or as a Chairperson of any Committee shall be entitled to run for a position in the **Board of Trustee (BOT)**. Any current member eligible to vote can run for a position in the **Executive Committee (EC)**.
 - B. **To be the President of the EC or the Chairperson** of the BOT, one must be a member of the Center for at least 3 years and must have served the Center for at least one year in any elected or appointed position.
 - C. No member of the Election committee shall run for any office.
 - D. No member shall contest for more than one position.
 - E. A trustee may not contest for another elected position except during the final year of his/her term, unless the trustee resigns from the BOT effective at the end of the election year.
 - F. The four members at large, Vice President, and the Joint Secretary of the EC shall be **required to hold chairmanship** of any committee under EC as advised by the President.

2. Nominee and nominators must be member of Hindu Center in good standing. .
3. The Secretary of the Executive Committee must receive completed form by **800 pm on November 09-2006, Thursday**.

7. **You must be a member by September 30, 2006 to vote.** (Refer Hindu Center Constitution for detail)
